**Registration:** Grillers will meet with the judges for a mandatory meeting at 5pm Friday Feb 15, 2019. Grillers are allowed to setup/cook any time after the meeting.

**Judging:** Judging will be done in one round. Each griller must submit samples in the unidentified containers given to them at registration at 9am for pork butts and 10am for ribs. Judges decisions are final.

**Rules:** All entries must be cooked on the official BBQ contest grounds. The BBQ Contestant is responsible for observing accepted and prudent temperature and sanitary requirements. A copy of the Southern BBQ Network rules is attached from their website.
