The Grand Champion (or the Reserve if the Grand Champion declines) will receive an automatic invitation to the annual SBN Invitational to compete for the title of SBN Champion.</p>

Southern BBQ Network Terms and Conditions for Sanctioned Events

The Contest Organization and its representative agree to the following conditions:

1. The Contest Organization and the representative agree to and abide by Southern BBQ Networks rules and judging criteria, including guaranteeing, and paying prize monies as published/ advertised to competing teams at the end of the contest. Prize monies may **NOT** be reduced after publication, and sanctioning has been given.
2. The name and information of the Contest Representative, as prescribed on page 1 of the application, is to be the primary contact individual for the SBN Event Representative.
3. Provide a current Certificate of Insurance for a minimum of \$ 1,000,000.00 of coverage, 90 days (about 3 months) before the contest date, with the Southern BBQ Network named on the document.
4. Provide materials, supplies, and support personnel as requested by SBN and its Event Representative to facilitate a successful contest.
5. Provide to SBN, upon request and free of charge, a space accessible to the public cook area, or near the judging area, for SBN and its sponsors to advertise, promote and sell its non-competing products.
6. The Contest Organization agrees to use SBN’s official logo on all contest materials, including but not limited to promotional items, advertisements, banners, signage, t-shirts, and all other materials after sanctioning has been approved.

Any violations of these conditions by the Contest Organization and their representatives contained in this agreement, will at the sole option of the Southern BBQ Network, cause this agreement to be null and void. In that event, the Southern BBQ Network will withdraw sanctioning and will not provide services to the contest. The contest will forfeit all monies and fees paid to the Southern BBQ Network.

By signing and submitting *The Southern BBQ Network Sanctioning Application and Agreement*, the Contest Organization and its representative agree to hold The Southern BBQ Network, their members, and volunteers harmless from any and all claims, suits, and proceedings of any nature which may be brought against them on account of any action, non-action on the part of the Contest and their representatives including any injuries to the person or property received during or related to the event this Sanction Request is applied for.
